



SIGHT DISTANCE TRIANGLE FOR ANY STREET/DRIVEWAY INTERSECTIONS WITH THOROUGHFARES

S 17<sup>th</sup> St is a major thoroughfare [Chap VII (C) (2) (a) of CofW Tech Stds]. In accordance with the City Code, sight distances along thoroughfares must be calculated in compliance with the AASHTO requirements. [Chap VII (C) (1) (8) Page 7-12 of CofW Tech Stds] [Sec.18-556 CofW LDC]. Show AASHTO sight distances for departure in addition to 20'x70' SDT for driveways.

### **TECHNICAL STANDARDS – PARKING:**

- 2. Dimension the width of parking spaces.
- 3. Show the typical handicap sign detail on the plan as per ADA and City standards. [Detail No.: TE7-01 & TE7-02] [CofW Sign Specification and Installation Guide]
