LANDSCAPING REQUIREMENTS

LANDSCAPE REQUIREMENTS FOR 10-25% EXPANSION

TREES REQUIRED: 15 TREES PER DISTURBED AREA x 0.58 AC
TREES PROVIDED: 24 EXISTING TREES TO REMAIN AND WILL BE PROTECTED ON SITE DURING CONSTRUCTION

STREETYARD REQUIRED: PRIMARY FRONTAGE / OLEANDER DRIVE
1/2 OF REQUIRED FOR NEW CONSTRUCTION
RB ZONE MULTIPLIER: 25 / 2 = 12.5
OLEANDER DR. FRONTAGE - DRIVEWAY WIDTH = 126'
SQ FT REQUIRED: 126 x 12.5 = 1,575 REQUIRED
SQ FT PROVIDED: 1,721 SQ FT

PLANTING REQUIREMENTS:
1/2 OF REQUIRED FOR NEW CONSTRUCTION
TREES REQUIRED: (1,623 / 600) = 3

INTERIOR TREES REQUIRED (1 PER ISLAND): 8
INTERIOR TREES PROVIDED: 9

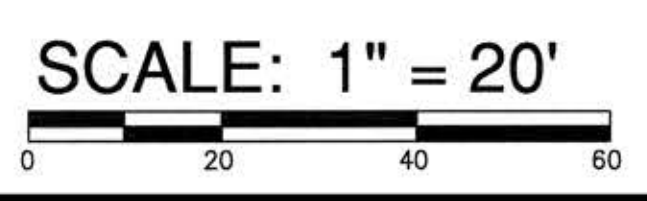
PARKING LOT SCREENING:
EXISTING VEGETATION AND NEW PLANTINGS WILL PROVIDE MAXIMUM OPACITY OF VEHICLE HEADLIGHTS.

BUFFER YARD REQUIREMENTS: FENCE OR HALF THE WIDTH REQUIRED FOR NEW CONSTRUCTION
BUFFER ZONE PROVIDED ADJACENT TO M-F M ZONED PROPERTY
NEW 6" MINIMUM OPAQUE WOODEN FENCE ON PROPERTY LINES ADJACENT EXISTING TREES AND VEGETATION WILL PROVIDE VISUAL OPACITY OF NEW FENCING.

FOUNDATION PLANTINGS: REQUIREMENTS: NONE
PROVIDED: 514 SQ FT

ALL PLANTINGS ARE TO BE MULCHED TO A DEPTH OF 3" WITH PINE NEEDLES OR CHOCOLATE CYPRESS MULCH.

ALL EXISTING VEGETATION TO REMAIN WILL BE CLEANED OF WEEDS AND PRUNED TO MAINTAIN OR IMPROVE THE HEALTH OF THE PLANTS.
